Vide ref 1st cited , the Executive Vice-Chairman, APCNF ,A.P RySS , Guntur has informed that the A.P RySS is contemplating to promote 5 Layer (36'x 36') crop models for small & marginal farmers under APCNF program during this FY 2020-21 and requested to redesign the existing Horticulture program within the permissible frame work under MGNREGS

- Accordingly vide ref 2nd cited, the redesigned work permitting 5 types of fruit tree species instead of single fruit species exclusively for Small & Marginal farmers in the villages selected under APCNF program was communicated to EVC, APRySS, APCNF, Guntur.
- 3. Vide ref 3rd cited, certain modifications were suggested by EVC, APRySS, APCNF, Guntur in the Horticulture Multi Cropping model and additional works were also requested to be considered in the same plot of land to promote the 5 layer model of Natural farming in view of its profitability & sustainability.
- 4. In this regard, after inclusion of modifications suggested by EVC, APRySS, APCNF, Guntur, the template for "Horticulture Multi Cropping in APCNF villages" under MGNREGS work is redesigned as follows.

- 5. The provision for farm ponds is an already existing work under MGNREGS & can be taken up on the same plot of land owned by the APCNF farmers.
- 6. The works shall be implemented in MCC duly following the MGNREGS guidelines & technical procedures in coordination with APCNF staff at District, cluster & village level.
- 7. The technical procedures involved from Estimate generation to FTO upload will be taken up the MGNREGS functionaries
- 8. The identification of the farmers & execution of work at field level will be the responsibility of APCNF functionaries.
- 9. This work will be allowed in 4003 selected APCNF villages only & the necessary software for generating the estimates will be deployed.
